To give a specific gift amount. “To pay to Scarborough Health Network Foundation (charitable registration number: 11914 2263 RR0001) the sum of \$_____ (e.g. \$50,000) for the benefit of Scarborough Health Network (or one of SHN’s three hospitals).”

To give a specific asset, such as shares in a company. “To give to Scarborough Health Network Foundation (charitable registration number: 11914 2263 RR0001) _____ shares of _____ for the benefit of Scarborough Health Network (or one of SHN’s three hospitals).”

To give a contingent gift. “In the event that my sister does not survive me, I give \$_____ to Scarborough Health Network Foundation to be used for the benefit of Scarborough Health Network (or one of SHN’s three hospitals).”

To designate your gift to a specific purpose. “To pay to Scarborough Health Network Foundation (charitable registration number: 11914 2263 RR0001) _____ share of the residue of my estate (or the sum of \$_____) to benefit Scarborough Health Network’s _____ (e.g. Research and Education Centre, cancer care).”

If you specify a particular program (e.g. cancer, dialysis), we suggest that you add a “Power to Vary” clause in your Will, for example “If at the time of my death it is impossible, impractical or inadvisable to apply the gift to this purpose, the Foundation may at their discretion direct the gift to a similar purpose.”
